**SYNOPSIS:**

The victim came to the police department to report she had been assaulted by her boyfriend in her apartment. Through investigation it was discovered that her boyfriend had used force to keep her in her apartment and strangled her and assaulted her while inside.

**INVESTIGATION:**

On Saturday, November 19th, 2022, \_\_\_\_\_ came to the Bowling Green Police Department to report she had been assaulted by her boyfriend, Jackson Martin.

\_\_\_\_\_ advised in the early hours of November 19th, 2022, Martin and his friend Payton Wright were at her house. \_\_\_\_\_ advised that Martin became angry and started arguing with her. \_\_\_\_\_ stated during the argument; Martin became very upset to the point Wright told her to go into her bedroom and lock the door. \_\_\_\_\_ advised once she was in her bedroom, Martin began to bang on her door and yell at her. \_\_\_\_\_ advised Wright was eventually able to get Martin to leave the residence around 0600 hours. \_\_\_\_\_ stated when they left the apartment, she locked the door and went to bed.

\_\_\_\_\_ stated sometime around 0700 hours, she heard a vehicle park outside and then heard someone trying to open her front door. \_\_\_\_\_ advised the subject left the front door, but she then heard someone try to open her window. \_\_\_\_\_ advised her window was messed up and could open if a latch was not pulled properly. \_\_\_\_\_ stated she attempted to lock the window, but then the subject, later identified as Martin, was able to open it and come inside the residence. \_\_\_\_\_ advised she asked Martin to leave the residence, and he would not. \_\_\_\_\_ stated that Martin eventually sat down on the bed, and she sat down as well. \_\_\_\_\_ advised they stayed on her bed until around 1200 hours. \_\_\_\_\_ advised she then got up and tried to clean the house and take a shower. \_\_\_\_\_ stated Martin was not violent during this time just kept asking her questions.

\_\_\_\_\_ advised when she had gotten out of the shower, Martin came into the bathroom and started yelling at her. \_\_\_\_\_ stated when this occurred, she had just gotten out of the shower and was wearing a towel. \_\_\_\_\_ advised while she was in the bathroom with Martin, he would not let her leave. \_\_\_\_\_ stated when she tried to leave the bathroom; Martin would push her into the shower. \_\_\_\_\_ advised after trying a few times; she just stayed sitting in the shower. \_\_\_\_\_ stated when she did this, Martin started yelling at her and putting toilet paper in the toilet, and throwing it at her. \_\_\_\_\_ stated Martin was also spraying her with Scrub Free bathroom cleaner. \_\_\_\_\_ advised she got away from Martin one time, but he grabbed her by the ankles and pulled her back into the bathroom. \_\_\_\_\_ advised it felt like she was in the bathroom for an hour during this incident. \_\_\_\_\_ advised at one point, she began to struggle with Martin again, trying to get out, and was able to get out of the bathroom.

\_\_\_\_\_ stated when she was out of the bathroom; she was able to get her phone and start a video with it. \_\_\_\_\_ advised she was able to hide the phone from Martin and that it was recorded while the assault occurred. \_\_\_\_\_ stated the video only had audio due to her hiding the phone.

I then asked \_\_\_\_\_ to walk me through what had happened the night before. \_\_\_\_\_ advised when she went to the bedroom, she attempted to lock the door, but Martin pushed his way in. \_\_\_\_\_ stated she ended up on her bed but did not remember how. \_\_\_\_\_ advised she sat on the bed and spoke with Martin for an unknown amount of time. \_\_\_\_\_ advised she stayed sitting on the bed because she was scared. \_\_\_\_\_ advised at one point, Martin seemed to calm down, so she got out of bed to put some clothes on.

advised when she did this; she put on Martin's mother's sweatshirt, which she had not thought about it. stated when she did this, Martin became upset and told her to take it off. advised when she took off the sweatshirt, Martin took it from her and ripped it. stated that Martin then became upset and pushed her onto the bed again.

advised she sat on the bed for a few minutes while Martin yelled at her. stated after a few minutes, she attempted to run towards the window to get out, but Martin grabbed her and threw her back onto the bed. advised Martin continued to yell at her, and when she did not answer him, he pushed her face down on her bed and put a pillow under her head. stated Martin then began to pull the pillow towards him, causing her to struggle to breathe. advised this lasted for roughly one minute, and then Martin let go of the pillow. advised when Martin did this; it made her feel like she was going to pass out. stated when Martin let go; she was still having trouble catching her breath.

advised after catching her breath, she sat on the bed again and listened to Martin yell at her. stated at one point, she attempted to get off the bed and get away from Martin, but he grabbed her and threw her on the floor. advised when Martin did this, she hurt her foot and started screaming. stated when she started screaming, Martin got on top of her and covered her mouth with his hands. advised when he did this, she tried to fight him off of her and tried to scream for help. stated when Martin covered her mouth and nose she was unable to breathe and felt like she might die. advised once Martin let go of her, she attempted to get out the door, but Martin blocked her. stated she then ran towards the window and was able to jump out of it.

stated when she got out of the window, she saw Martin's vehicle and went to it because he commonly left the keys in it and left it unlocked. advised she took the vehicle around the block until she thought it was safe for her to go back home. stated she passed Martin a few blocks away from her residence, and that's when she went back home, got her pet, and went to the police department.

After made her statement, I asked if she could walk me through the video she took of the incident. advised yes and then informed me the first part of the video was just Martin yelling at her. started the video around 14:30 into the video. advised around 14:47 on the audio, you hear her tell Martin to stop, and then he pushed her onto the bed. advised about ten seconds later, she attempted to get out of the bedroom, and Martin threw her onto the bed. At 15:13, you hear Martin say to , "you're not done with your torture yet. so you sit right there, and fucking take it." Martin can then be heard saying, "your lucky, you know why? I didn't slap you; I didn't punch you; I didn't kick you. Goddam, you think this is bad? you have no idea I'm going easy on you." Martin then stated, "should I go a little harder? Do you want to get punched? Do you want to get slapped? I want to slap you. I probably will." Martin then stated, "now everyone will know. You've got my mark. A bigass welt on your face for like a week."

advised around 17:05, Martin pushed her onto the bed and used the pillow on her. You can hear tell Martin to stop then you hear what sounds like struggling to breathe. At 18:08, you hear say, "I can't breathe."

advised at 20:35, she had picked up scissors from her desk but threw them back down when she saw the look in Martin's eye. Martin is then heard on the audio telling to pick up the scissors, or he will stab himself. then stated that Martin advised he was going to cut her so she would always remember him. advised she did not pick them up, and when she didn't, Martin took them and attempted to cut himself. stated she then struggled with Martin to take the scissors away. stated she was able to get the scissors away and throw them across the room. advised when she

did this, Martin picked her up and threw her onto the floor. pain in her right foot.

stated when Martin did this it caused

advised Martin, then got onto the floor because she was screaming in pain, and he covered her mouth with his hand. stated when Martin did this, she was unable to breathe and thought she was going to die. advised Martin eventually let go and she was able to jump out of the bedroom window.

After speaking with , I completed an IPO request that was submitted to Judge K.Geoghegan Judge Geoghegan approved the EPO. was served with her copy of the EPO while at the police department.

After was served her paperwork, she allowed me to follow her to her residence to photograph the scene. See the Crime Scene Processing section for further. While at the residence, I did observe wet toilet paper in the shower, and I also observed a torn sweatshirt on bedroom floor. After processing residence, I then went back to the police department to listen to the full audio.

In the first part of the video, you can hear Martin talking to . Martin stated, "I don't care if someone barges in here and arrest me." Martin then stated, "I'll admit to what I did, and I'll laugh about it." Martin could then be heard making some statements and then saying, " I don't need anyone to define me. I'll go where I belong. I'll be smiling the whole time."

Martin then stated, " They don't look like they are going to bruise very badly. They are just a little red. I made sure not to grab you hard. I'm smart about abusing women. I know how to do it right." After this statement, Martin advised, "I am a devil, and I love it. Being evil is fun. I like to make people cry."

After reviewing the video Officer Carroll was able to make contact with Martin's mother, and she advised officers she would bring Martin to the police department. Around 2100 hours Martin arrived at the police department. I made contact with Martin in the front lobby, and I asked Martin if he would be willing to speak with me upstairs and speak with me. Martin advised that he would. Martin was then taken to the interview room inside the Criminal Investigation Division. Once inside the interview room, I read Martin Miranda Warning, and he agreed to speak with me.

After reading Martin Miranda Warning, I asked him to tell me what had occurred today. Martin advised he was supposed to go to a UK game in Lexington with a friend, but he and got into a big argument. Martin advised ran into her room and locked the door. Martin advised he did not wanna leave until he talked to her about the argument. Martin then stated he eventually did leave.

Martin then stated he left and came back to throw items from his house in her bedroom window. Martin stated when he did this; he accidentally fell through her window. Martin stated was upset and told him to leave. Martin advised and eventually allowed him to stay and talk with her. Martin stated that attempted to call the police at one point, and he took his phone away from her. Martin advised then attempted to leave the bedroom, and he grabbed her and asked her not to call the police. Martin stated that then punched him in the face and kicked and scratched him. Martin advised he tried to push back away from him. Martin advised every time hit him harder, he would push her harder.

Martin advised there was a time here kept hitting him in the bathroom, and he wouldn't let her go. Martin stated tried to leave the bathroom, and he didn't let her. Martin stated he drug her back into

the bathroom at that time. Martin advised [redacted] started screaming out loud, saying, "please don't kill me. Please don't kill me." Martin advised her, then covered her mouth so she couldn't scream and just kept whispering in her ear, "Please don't do this. I just wanna talk to, to you; please don't do this."

Martin stated after that, [redacted] went over to her dresser and grabbed a pair of scissors, and put it to his stomach. Martin advised he grabbed the scissors out of [redacted] hands, and while he did that, he cut his arm and hand. Martin advised after that, [redacted] and he finally just realized that maybe, maybe, he should just stop and let her go. Martin advised when he did this, [redacted] went through a window. Martin stated [redacted] got in his car and drove off, and he walked home.

Martin advised they were inside the bathroom for about 45 minutes before they went to the bedroom.

I then asked Martin why he would not let [redacted] go, and he stated, "Well, I just, a part of me feels like I needed to fix that situation right now, and I didn't think that problem would ever be solved if I just let her go."

I also asked Martin why he put his hand over [redacted] mouth, and he advised he didn't want to get into trouble. When I asked Martin why he thought he would have gotten in trouble he stated "because there have been times in the past where she's told people that I punched her in the face, uh, tried to stab her with a knife and I've never done anything like that. Okay. You know, I might've shoved her. I might have pushed her off of me. I might have grabbed her while she was running away, but I never tried to stab her with scissors. I never punched her in the face. I never smacked her in the face."

I asked Martin to go more in-depth about the scissors, and he advised she stood up on the bed and grabbed him by the throat, and was shoving him back. Martin stated [redacted] then reached over to grab a pair of scissors, and when she did, he backed up and looked her in the eyes. Martin stated he thought, "like, are you really gonna do this? Like, are you really pointing a pair of scissors at me?" Martin stated [redacted] had the scissors to his stomach.

While speaking with Martin, he advised he did cover [redacted] mouth with his hand two times. Martin advised once when [redacted] was in bed and once when [redacted] was on the floor. Martin stated when [redacted] was on the floor, she did say she couldn't breathe, and he let go of her.

At this time, I left Martin in the interview room and stepped out of the room.

When I went back into the room, I informed Martin I had evidence in reference to this case, and it was telling me a different story than he was telling me. I then asked Martin to tell me more about the scissors. Martin then advised he cut himself with the scissors. Martin stated that [redacted] did put the scissors to his chest, but he was able to take them away from her then he tried to cut his arm with them. I then asked Martin if this had just happened, and he advised he had thought about punishing her for what she had done to him. When I asked Martin how he would have punished her, he stated, "In the past, I have traumatized her by putting my hands on her, saying mean things to her, threatening her."

I then asked Martin about him putting his hands over [redacted] mouth, and he advised one of the times was with a pillow, not his hands. Martin stated he used the pillow to cover her mouth, and then he stopped when [redacted] advised she couldn't breathe.

I then asked Martin about the incident with the scissors. Martin advised he threw the scissors across the room. Martin stated after throwing the scissors, [redacted] was trying to run to the door, and I tackled her. Martin stated [redacted] was just screaming for help, and he ended up on his back, and he wrapped his legs

around her. Martin advised nothing was really said other than her trying to speak over his hand.

I then asked Martin about him being forceful, and he advised, "I was just being hard, it wasn't just covering, I was trying to hold her body and trying to get her to stop her head from moving. And I was being pretty forceful with it." Martin stated when he let go, got right back up and jumped out the window.

I asked Martin what his intentions were when he went back to house, and he stated, "at first, I wanted to see if she would be willing to talk things out with me, but there was no doing that. It was clear that there was no doing that." Martin then stated, "it wasn't an impulse decision. I genuinely chose to do what I did."

The interview was recorded via body camera and interview camera.

At this time, I stepped out of the room while Officer Ward went and picked up the EPO that needed to be served. Once the EPO was retrieved, I went back into the room and placed Martin under arrest. Martin was then transported to the Warren County Regional Jail. While there, I read Martin the EPO and served it on him.

On Sunday, November 20th, 2022, I made contact with Payton Wright via phone. While speaking with Wright, I asked him what had occurred while he was at house. Wright then advised that he was at apartment with Martin and . Wright advised while at the apartment, Martin became upset with and started yelling at her. Wright stated that Martin was getting so mad that he had to grab him and pull him away from door. Wright advised that the argument lasted for about three hours, and he was trying to get Martin out of the apartment the entire time. Wright advised that Martin had drank alcohol earlier in the day but stated he appeared not to be intoxicated when he left the apartment. Wright stated Martin drove him to his house and dropped him off once they left apartment.

### Crime Scene Processing

I took photos of the victim and the victim's residence. I also collected the video the victim recorded. There were also photos taken of Martin and his injuries from falling into the window. These photos and videos will be logged into evidence.
